ACT

To appropriate adjusted amounts of money for the requirements of the Province in respect of the financial year ending 31 March 1999.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows:

(Afrikaans text signed by the Premier.) (Assented to 2 March 1999)

Appropriation of adjusted amounts of money for requirements of the Province

Subject to the provisions of the Exchequer Act, 1994 (Act No 1 of 1994), there are 1. hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province in respect of the financial year ending 31 March 1999, as a charge to the Provincial Revenue Account, the adjusted amounts of money shown in column 1 of the Schedule.

Short title

2. This Act shall be called the Adjustments Appropriation Act, 1999.
