## ACT

**To appropriate adjusted amounts of money for the requirements of the Province in respect of the financial year ending 31 March 2010**

**BE IT ENACTED** by the Provincial Legislature of the Free State Province, as follows:-

**Appropriation of adjusted amounts of money for requirements of the Province**

1. Subject to the provisions of the Public Finance Management Act, 1999 (Act No. 1 of 1999), there are hereby appropriated out of the Provincial Revenue Fund for the requirements of the Province in respect of the financial year ending 31 March 2010, as a charge to the Provincial Revenue Account, the adjusted amounts of money as set out in the Columns under "Details of adjusted appropriation" in the Schedule. 10
