ACT

To amend the Commissions Ordinance, 1954, so as to expand the subjects for which commissions of enquiry may be appointed; and to make provision for matters in connection therewith.

 ${f B}^{\rm E}$ IT ENACTED by the provincial legislature of the Orange Free State Province, as follows:-

Amendment of section 1 of Ordinance 5 of 1954

- 1. Section 1 of the Commissions Ordinance, 1954 (hereinafter referred to as the Ordinance), is amended -
 - (a) by the deletion of the definition of "Administrator"; and
 - (b) by the insertion after the definition of "commission" of the following definition:

"'Premier' means the Premier of the province acting in terms of section 147(1)(d) of the Constitution of the Republic of South Africa, 1993 (Act No 200 of 1993);".

Amendment of section 2 of Ordinance 5 of 1954

- 2. Section 2 of the Ordinance is amended by the substitution for subsection (1) of the following subsection
 - "(1) The [Administrator] Premier may by proclamation in the Provincial Gazette appoint a commission to enquire into and report upon any matter relating to a subject in respect of which a provincial [council] legislature has legislative [power] competence or a province has executive authority."

Act No 2, 1995

Substitution of certain expressions in Ordinance 5 of 1954

- 3. The Ordinance is amended -
 - (a) by the substitution for the expression "Administrator", wherever it occurs, of the expression "Premier"; and
 - (b) by the substitution for the expression "Gazette", wherever it occurs, of the expression "Provincial Gazette".

Short title and commencement

4. This Act shall be called the Commissions Ordinance Amendment Act, 1995, and shall be deemed to have commenced on 24 June 1994.
