#### **GENERAL EXPLANATORY NOTE:**

#### **ACT**

To amend the Exchequer Act, 1994, so as to define anew certain expressions and to further provide for delegation of powers by accounting officers.

(Afrikaans text signed by the Premier.) (Assented to 27 September 1994)

**B**E IT ENACTED by the provincial legislature of the Orange Free State Province, as follows:-

### Amendment of section 1 of Act 1 of 1994

- 1. Section 1 of the Exchequer Act, 1994 (hereinafter referred to as the principal Act), is hereby amended -
  - (a) by the substitution for the definition "department" of the following definition:
  - "'department' means a department of the Province mentioned in the first column of the Schedule to the Provincial Service Commission Act, 1994 (Act No 3 of 1994);"; and
  - (b) by the substitution for the definition of "head of department" of the following definition:
    - "head of department' means an officer bearing the designation mentioned in the second column of the Schedule to the Provincial Service Commission Act, 1994, opposite the name of the relevant department;".

#### Amendment of section 24 of Act 1 of 1994

- 2. Section 24 of the principal Act is hereby amended by the addition of the following subsection:
  - "(5) An accounting officer may, subject to section 19(2), delegate any power conferred upon him or her by the Regulations, to the holder of any post on the establishment of the Province and for the purposes of that delegation section 19(3) and (5) mutatis mutandis apply."

#### Amendment of section 25 of Act 1 of 1994

- 3. Section 25 of the principal Act is hereby amended by the addition of the following subsection:
  - "(4) An accounting officer may, subject to section 19(2), delegate any power conferred upon him or her by the Instructions, to the holder of a post on the establishment of the Province and for the purposes of that delegation section 19(3) and (5) shall mutatis mutandis apply."

EXCHEQUER AMENDMENT ACT, 1994

### Short title and commencement

4. This Act shall be called the Exchequer Amendment Act, 1994, and shall be deemed to have come into operation on 1 July 1994.
