### **ACT**

To provide for the fixing of remuneration and other conditions of service of staff of the provincial legislature, and for matters incidental thereto.

(English text signed by the Premier.) (Assented to 14 December 1994)

<b>B</b> EIT ENACTED by the provincial legislature of the Orange Free State Province, as follows:	5
Remuneration and conditions of service of staff of the provincial legislature	10
1. (1) The remuneration and other conditions of service of a person contemplated in section 143(2) of the Constitution of the Republic of South Africa, 1993 (Act No 200 of 1993), who is appointed as a member of the staff of the provincial legislature shall, subject to subsection (2), be fixed by the Executive Council of the Province after consultation with the Standing Committee on Rules and Orders of the said provincial legislature.	15
(2) A person contemplated in subsection (1) and who is employed in terms of the Public Service Act, 1994, shall receive the remuneration and shall be subject to the other conditions of service as may be determined by or under the Act.	20
Savings	25
2. Any remuneration paid to a person contemplated in section 1 after 27 April 1994, but before a fixing of his or her remuneration was made in terms of section 1(1), shall be deemed to be remuneration fixed under this Act.	30
Short title and commencement	
3. This Act shall be called the Fixing of Remuneration and Other Conditions of Service of Staff of the Provincial Legislature Act, 1994, and shall be deemed to have come into operation on 27 April 1994.	35
