ACT

To extend the application of the Road Traffic Act, 1989, throughout the Province; to repeal certain other road traffic laws; and to provide for connected matters.

BE IT ENACTED by the Provincial Legislature of the Free State Province, as follows: 5 (English text signed by the Premier.) (Assented to 31 March 1998) Extension of application of the Road Traffic Act, 1989 10 1. The Road Traffic Act, 1989 (Act No 29 of 1989), shall apply throughout the Province. Repeal of laws and savings 15 2. (1) Subject to the provisions of subsection (2), the laws mentioned in the Schedule are hereby repealed to the extent indicated in the third column of the Schedule. (2)Anything done under a law mentioned in the Schedule and which is capable of being done under a provision of the Road Traffic Act, 1989 (Act No 29 of 1989), 20 shall be deemed to have been done in terms of the corresponding provision of the said Act. Short title and commencement 25 3. This Act shall be called the Free State Road Traffic Application Act, 1998, and shall be deemed to have come into operation on 1 March 1998.
