**ACT**

**To amend the Free State Youth Commission Act, 1996, as to provide for a new definition, to define anew certain expression, to provide for the age limit of youth Commissioners and to provide for incidental matters.**

**BE IT ENACTED** by the Provincial Legislature of the Free State, as follows:-

*(Afrikaans text assented to and signed by the Premier.)*

**Amendment of section 1 of Act 4 of 1996, as amended by Act 1 of 2001**

1. Section 1 of the Free State Youth Commission Act, 1996 (hereinafter referred to as "the principal Act") is amended -

(a) by the substitution for the definition of "**Constitution**" of the following definition:

"**Constitution**" means the Constitution of the Republic of South Africa, 1996 [(Act No. 108 of 1996)];";

(b) by the insertion of the definition of "**youth**" after the definition of "**responsible Member**"

"**youth**" means persons between the ages of 14 and 35;".

**Amendment of section 4 of Act 4 of 1996, as amended by Act 1 of 2001**

2. Section 4 of the principal Act is amended by the substitution for subsection (2) of the following subsection:

"(2) A member of the Commission shall vacate his or her office -

(a) if he or she resigns;

(b) if he or she is absent from 3 consecutive meetings of the Commission without the prior leave of the chairperson; [**or**]

(c) when he or she attains the age of 36; or

[(c)](d) if his or her term of office is terminated under subsection (3).".

**Short title**

3. This Act is called the Free State Youth Commission Amendment Act, 2007.

                       (b) as hy of sy by drie agtereenvolgende vergaderings van die Kommissie afwesig is sonder vooraf toestemming van die voorsitter; [of]  
                       (c) wanneer hy of sy die ouderdom van 36 bereik; of  
                       [(c)](d) as sy of haar ampstermyn kragtens subartikel (3) beeindig word.".
