PROVINCIAL NOTICE

[No. 229 of 2010]

REGULATIONS IN TERMS OF THE FREE STATE PUBLIC TRANSPORT ACT, 2005 (Act No. 4 of 2005)

ESTABLISHMENT OF A JOINT MANAGEMENT ROUTE COMMITTEE FOR THE BLOEMFONTEIN-BOTSHABELO-THABA NCHU AND BRANDFORT ROUTE

By virtue of section 41(1) of the Free State Public Transport Act, 2005 (Act No. 4 of 2005), read with Regulation 9 of the Free State Public Transport Regulations, 2010, I, Thabo Moses Manyoni, Member of the Executive Council responsible for Police, Roads and Transport in the Province, hereby establish a Joint Management Route Committee for the Bloemfontein-Botshabelo-Thaba 'Nchu and Brandfort route.

The members of the Joint Management Route Committee (hereinafter referred to as the "Committee"), are set out in the Schedule and the functions will be as prescribed in terms of these Regulations.

SCHEDULE

Definitions

- 1. In these regulations, any word or expression to which a meaning has been assigned in the Act, shall have the meaning so assigned, unless the context indicates otherwise, and
 - "Joint Management Route Committee" means a committee established by the MEC in terms of section 41(1) of the Act;
 - "route" means area of operation or roads that have been allocated to an operator and they are described on the permit or operating licence; and
 - "the Act" means the Free State Public Transport Act, 2005 (Act No. 4 of 2005).

Meetings of the Committee

- 2. (1) The Committee must meet at least once a quarter.
 - (2) The chairperson or acting chairperson may call an emergency meeting whenever a need for such meeting arises.

- (3) The chairperson may decide on the venue and time for the meetings of the Committee.
- (4) A member ceases to be a member if he or she absents himself or herself from the meeting for three consecutive sittings without a written apology.

Disqualification of members

- 3. A member is disqualified from being a member of the Committee if
 - (a) he or she is declared insolvent and is not rehabilitated;
 - (b) he or she is declared incapable of managing his or her own affairs by a competent court;
 - (c) he or she acts in improper manner that bring the dignity of the Committee into disrepute;
 - (d) he or she is convicted and sentenced to prison without an option of a fine;
 - (e) he or she conducts himself or herself in terms of the provision of Regulation 2(4) above;
 - (f) he or she acts in a manner that impedes the functioning of the Committee;
 - (g) on good cause shown, the MEC directs that a member's membership be terminated; and
 - (h) he or she resigns or dies.

Vacancies in the Committee

- 4. A vacancy that occurs in the Committee as a result of the provisions of Regulation 3 can be filled as follows:
 - (a) by a nomination from the relevant stakeholder and the name of nominated member being published in the Provincial Gazette;
 - (b) by the MEC directing that a particular replacement member be nominated in terms of the powers vested in him by virtue of Regulation 9(2)(b) of the Free State Public Transport Regulations, 2010; and
 - (c) a member who is nominated for the unfinished term of office which is created in terms of the provisions of Regulation 3, only serves for the unexpired term that is left.

Allowance for members of the Committee

5. (1) Members of the Committee who are not public servants will be given a sitting allowance for sitting, which is determined by the MEC in consultation with the MEC for Finance; and

(2) Members of the Committee who are public servants may submit their claims for reasonable and necessary subsistence and travelling allowances.

Short title

6. These Regulations are called the Joint Management Route Committee for Bloemfontein-Botshabelo-Thaba 'Nchu and Brandfort Route Regulations, 2010.
