# ACT

To authorise certain unauthorised expenditure and to provide for matters connected therewith.

**BE IT ENACTED** by the Provincial Legislature of the Province, as follows:-

*(English text assented to and signed by the Premier on 27 March 2013.)*

## Authorising of expenditure

5

1. (1) The unauthorised amount of R 226, 407, 072.66 set out in the Schedules which –

(a) the Provincial Account Committee recommended for authorisation by the Provincial Legislature;

(b) is more fully described in the Report of the Auditor General of South Africa on the Annual Financial Statements for the financial years 2010/11 and 2011/12; and

(c) were set out in relation to the Department of Health in Finance Act, 2009 (Act No. 8 of 2009) and Finance Act, 2011 (Act No. 1 of 2011) and which were not fully implemented by the Department of Health,

is hereby authorized in terms of section 34 of Public Finance Management Act, 1999 ( Act No.1 of 1999) in the manner set out in subsection (2).

(2) The unauthorised amounts referred to –

(a) in the second column of Schedule A, which represents unauthorised expenditure resulting from overspending of the vote referred to in the first column of Schedule A. R 50, 790, 723 and R 43, 529, 000 were previously enacted by Finance Act, 2009 and Finance Act, 2011 as charges against the relevant Vote, but in terms of this Act they become direct charges against the Provincial Revenue Fund in the 2012/13 and 2013/2014 financial years, respectively;

(b) in the second column of Schedule B, which represents unauthorised expenditure resulting from another reason than overspending of the Vote, become direct charges against the Provincial Revenue Fund during 2012/2013 financial year; and

(c) in the second column of Schedule C, which amount represents an unauthorised expenditure resulting from another reason than overspending of the Vote, become a direct charge against the relevant Vote in the financial year indicated in column 3.
