ACT

To amend the Powers, Privileges and Immunities of the Provincial Legislature Act, 1996, so as to make the Auditor-General Act, 1995, applicable on the financial arrangements of the Provincial Legislature.

REIT ENACTED by the Provincial Legislature of the Free State Province, as follows:-

Amendment of section 28 of Act 3 of 1996

- Section 28 of the Powers, Privileges and Immunities of the Provincial Legislature Act, 1996, is amended by the substitution for subsection (9) of the following subsection:
 - The accounts of the Provincial Legislature shall, subject to the provisions of "(9)subsection (1), be investigated, examined and audited by the Auditor-General, and in the carrying out of such an audit the provisions of [sections 5(1), 5(7)(a) and (b) and 5(8), 6(1) and (2A), 7 and 14(1) and (1A) of the Auditor-General Act, 1989 (Act No. 52 of 1989),] section 193 of the Constitution and sections 3(4)(a) and (b) and 3(5), 4(1), 5 and 8(1) and (2) of the Auditor-General Act, 1995 (Act No. 12 of 1995), shall mutatis mutandis apply, and in such application the references in sections [5(1) and 6(1),] 193 and 4(1), to an accounting officer and to persons in the public service shall be deemed to be references to the Secretary and to persons in the employ of the Provincial Legislature, respectively.".

Short title

This Act shall be called the Powers, Privileges and Immunities of the Provincial Legislature Amendment Act, 1996.

ACT

To amend the Powers, Privileges and Immunities of the Provincial Legislature Act, 1996, so as to make the Auditor-General Act, 1995, applicable on the financial arrangements of the Provincial Legislature.

RE IT ENACTED by the Provincial Legislature of the Free State Province, as follows:-

Amendment of section 28 of Act 3 of 1996

- 1. Section 28 of the Powers, Privileges and Immunities of the Provincial Legislature Act, 1996, is amended by the substitution for subsection (9) of the following subsection:
 - "(9) The accounts of the Provincial Legislature shall, subject to the provisions of subsection (1), be investigated, examined and audited by the Auditor-General, and in the carrying out of such an audit the provisions of [sections 5(1), 5(7)(a) and (b) and 5(8), 6(1) and (2A), 7 and 14(1) and (1A) of the Auditor-General Act, 1989 (Act No. 52 of 1989),] section 193 of the Constitution and sections 3(4)(a) and (b) and 3(5), 4(1), 5 and 8(1) and (2) of the Auditor-General Act, 1995 (Act No. 12 of 1995), shall mutatis mutandis apply, and in such application the references in sections [5(1) and 6(1),] 193 and 4(1), to an accounting officer and to persons in the public service shall be deemed to be references to the Secretary and to persons in the employ of the Provincial Legislature, respectively.".

Short title

2. This Act shall be called the Powers, Privileges and Immunities of the Provincial Legislature Amendment Act, 1996.
