ACT

To amend the Provincial Service Commission Act, 1994, so as to substitute the Schedule.

(English text signed by the Premier.) (Assented to 31 Mei 1995)

RE IT ENACTED by the provincial legislature of the Orange Free State Province, as follows:

Substitution of the Schedule to Act 3 of 1994

1. The Provincial Service Commission Act, 1994, is hereby amended by the substitution for the Schedule of the following Schedule:
