The laws mentioned in Schedule 1 shall apply throughout the Province. 1.

Repeal of laws and savings

- Subject to the provisions of subsection (2), the laws mentioned in Schedule (1) 2 are hereby repealed.
- Anything done under a law mentioned in Schedule 2 and which is capable of being done under a provision of a law mentioned in Schedule 1, shall be deemed to have been done under such provision of such law.
