Centlec is embarking on a project to convert all conventional/rotational meters to a pre-paid metes. There are approximately 25000 meters within the Mangaung metro that will be converted in this campaign. This is aimed at alleviating persistent problems with account disputes, incorrect billing and associated administration. This venture will also afford customers with an opportunity to closely manage their electricity consumption. It should be noted that Centlec reserves the right to determine the process or method of metering as a licensed electricity distributor in this area. All meters are a property of the Metro and are used as instruments of electricity distribution service in the Metro.
